November 8, 2010 Meeting

Called to order at 4:40 pm by President.

Secretary report accepted as presented Harriet/Emerson, unanimous.

Treasurer's report accepted as presented. Harriet/Rudi, unanimous. Dick reported that the audit was performed and acceptable.
